“ADOPTING THE 4TH REGIONAL STATISTICS COMMITTEE SUMMIT DECLARATION”

WHEREAS, the PSA Board created the Regional Statistics Committee (RSC) through PSA Board Resolution No. 5 Series of 2015 to serve as the policymaking body on statistical matters and venue for discussion and resolution of statistical issues at the local level;

WHEREAS, the RSC Summit is conducted every year to recognize the vital role of the RSC and to strengthen inter-regional statistical cooperation, coordination and collaboration among RSC members;

WHEREAS, during the 4th RSC Summit held last November 14-15, 2019 at the 1898 Hotel Colonia en Las Filipinas, Makati City, a Declaration was prepared and presented to seek commitment from government agencies, local government units, private organizations, and the general public to support the conduct of the 2020 Census of Population and Housing (CPH) and implementation of the Community-Based Monitoring System (CBMS);

WHEREAS, the Committee read and discussed the Declaration, and concurred to the objectives of the Declaration to widely promote the significance of the 2020 CPH and CBMS;

NOW THEREFORE, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED,** to adopt the 4th Regional Statistics Committee Summit Declaration and the action plan shown in Annex “A” which form part of this resolution;

BE IT RESOLVED FURTHER, to endorse to the Regional Development Council through the Sectoral Committee on Macroeconomy and Development Administration;
