2022 CALABARZON RSC Priority Thrusts and Activities

A. Statistical Planning and Coordination

1. Updating and endorsement of Regional Statistical Development Program (RSDP) 2018-2023 to the Regional Development Council for approval.
2. Preparation of monitoring report on RSDP 2018-2023.
3. Strengthening and monitoring of the adoption of Statistical Standards and Classification Systems by the regional line agencies and local government units
4. Coordination on the implementation of Community-Based Monitoring System
5. Assessment/deliberation of issues and recommendation of actions to address concerns on the compilation of Provincial Product Accounts
6. Coordination of Technical Working Group on Environment and Natural Resource Accounting for the compilation of CALABARZON Asset Accounts
7. Enjoining support to the 33rd National Statistics Month and 15th National Convention on Statistics
8. Conduct of RSC quarterly meetings with at least 81 percent participation rate

B. Statistical Advocacy

1. Compliance with the Fundamental Principles of Official Statistics
2. Harmonization of administrative records and data compilations to conform with statistical standards and classifications
3. Address data gaps in the establishment of Regional Sustainable Development Goal Indicators and Core Regional Indicators
4. Sustainable information and advocacy campaign for public awareness on the importance of statistics for evidence-based policies and planning development

C. Data Generation

1. Approval of the CALABARZON SDG Watch showing measures in progress tracking
2. Coordination and consolidation of quarterly data for the Regional Economic Situationer and annual data for the Regional Development Report
3. Improvement in the generation of administrative data on road crash, disaster statistics and overseas Filipinos

1. Maintenance and updating of the CALABARZON Regional Social and Economic Trends publication
2. Updating and monitoring of the CALABARZON Integrated Statistics Web Portal
