**RSC Resolution No. IV-A-12-2021**

**“ENJOINING THE REGIONAL GOVERNMENT AGENCIES AND INSTRUMENTALITIES, STATE UNIVERSITIES AND COLLEGES AND PRIVATE HIGHER EDUCATION INSTITUTIONS, AND LOCAL GOVERNMENT UNITS TO SUPPORT THE REMAINING SURVEY ACTIVITIES OF PHILIPPINE STATISTICS AUTHORITY FOR 2021”**

**WHEREAS,** Republic Act of 10625 also known as the Philippine Statistical Act of 2013 states that the Philippine Statistics Authority (PSA) shall prepare and conduct statistical sample surveys on all aspects of socioeconomic development;

**WHEREAS,** the success of these statistical survey undertakings of PSA also largely depends on the support of regional line agencies (RLAs), state universities and colleges (SUCs) and private higher education institutions (HEIs), and local government units (LGUs) through promotion, information and educational campaign, and cooperation of sample households and establishments in providing truthful information;

**WHEREAS,** the statistics generated from these surveys are crucial in crafting better policies leading to inclusive economic growth and development;

**WHEREAS,** the remaining survey activities of the PSA for 2021 are shown in “Annex A”, which forms part of this Resolution;

**NOW THEREFORE,** on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED,** to enjoin the regional government agencies and instrumentalities, state universities and colleges and private higher education institutions, and local government units to support the remaining survey activities of PSA for 2021.

**RESOLVED FURTHER,** to request the RLAs and other instrumentalities, SUCs and private HEIs, and LGUs in CALABARZON to conduct information and advocacy campaigns on the importance of the statistical surveys being undertaken by the PSA.
