"ENJOINING THE REGIONAL GOVERNMENT AGENCIES AND INSTRUMENTALITIES, AND LOCAL GOVERNMENT UNITS TO SUPPORT THE CONDUCT OF BUSINESS ESTABLISHMENTS SURVEYS AND UPDATING OF THE LIST OF ESTABLISHMENTS"

- WHEREAS, the Philippine Statistics Authority (PSA) is designated to conduct Monthly Integrated Survey of Selected Industries (MISSI) and Producer Price Survey (PPS), Quarterly Survey of Philippine Business and Industry (QSPBI), Annual Survey of Philippines Business and Industry (ASPBI), Survey of Tourism Establishments in the Philippines (STEP), and Updating of the List of Establishments (ULE);
- WHEREAS, the MISSI and PPS provide flash indicators on the performance of growthoriented industries in the manufacturing sector;
- WHEREAS, the QSPBI provides quarterly data on employment, compensation, revenue or sales, and inventories for the various sectors of the economy classified under the 2009 Philippine Standard Industrial Classification;
- WHEREAS, the ASPBI generates essential statistics for economic planning and analysis as well as collect and generate information on the levels, structure, performance, and trends of economic activities of the formal sector of the country;
- WHEREAS, the STEP collects information on the available supply of tourism goods, products, and services which are valuable inputs in the compilation of the Philippine Tourism Satellite Account;
- WHEREAS, the ULE provides an updated and reliable sampling frame for the census and surveys of establishments and enterprises as well as capture the changes in the distribution and characteristics of establishments and business units due to emerging industries and the current business trends;
- WHEREAS, the number of PSA's sample establishments which are not responding on time and cooperating on the aforementioned surveys is increasing in CALABARZON;
- WHEREAS, higher response rates would give more precise and reliable statistical indicators for policy makers and decision makers;
- NOW THEREFORE, on motion duly seconded, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to enjoin the regional government agencies and instrumentalities, and local government units to support the conduct of Business Establishments Surveys and Updating of the List of Establishments;
