“ENJOINING THE REGIONAL LINE AGENCIES, LOCAL GOVERNMENT UNITS, AND ACADEME TO PROVIDE ASSISTANCE IN PROMOTING THE DATA ENCLAVE CENTERS OF THE PHILIPPINE STATISTICS AUTHORITY”

WHEREAS, the Philippine Statistics Authority (PSA) is the central statistical authority of the Philippine government on primary data collection;

WHEREAS, as part of its commitment to bringing statistical products and services closer to its stakeholders and a new viable form of disseminating its products, the PSA has established and institutionalized Data Enclave Centers (DECs) in its Regional Statistical Services Office (RSSO) in 17 regions nationwide on July 14, 2023;

WHEREAS, a data enclave is a highly secure and specialized facility through which confidential data such as identifiable information and firm-level data from censuses and surveys can be stored and disseminated;

WHEREAS, the DEC in CALABARZON, located at PSA RSSO IV-A, Ground Floor, Building C of Fiesta World Mall, Barangay Maraouy, Lipa City, Batangas is now available and ready to serve researchers and other stakeholders;

WHEREAS, to foster the free or open use of the data in policy research, studies, thesis or academic papers, and similar materials, it is imperative to promote and market the DEC by posting IEC materials (social media cards, audio-visual material, press release) in regional websites and/or social media pages, discussing the DEC and its features in dissemination fora, and conducting information caravan showcasing the DEC;

NOW THEREFORE, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED,** to enjoin the regional line agencies, local government units, and academe to provide assistance in promoting the Data Enclave Centers of the Philippine Statistics Authority.
