RSC Resolution No. IV-A-01-2023

"ENDORSING TO THE CALABARZON REGIONAL DEVELOPMENT COUNCIL THE REQUEST TO ENJOIN THE REGIONAL LINE AGENCIES, LOCAL GOVERNMENT UNITS, STATE UNIVERSITIES AND COLLEGES, AND PRIVATE SECTOR REPRESENTATIVES IN THE FORMULATION OF THE CALABARZON REGIONAL STATISTICAL DEVELOPMENT PROGRAM 2023-2029"

- WHEREAS, the Philippine Statistical Act of 2013 mandates the Philippine Statistics Authority to formulate an up-to-date Philippine Statistical Development Program (PSDP) that will set the directions, thrusts and priorities of the Philippine/Regional Statistical System (P/RSS) in the generation and dissemination of statistical information needed for evidence-based policies and decision-making of the government, private sector and general public;
- WHEREAS, there is a need to formulate the PSDP 2023-2029 to support the Philippine Development Plan 2023-2028 with vital statistical information necessary in measuring the country's progress and formulating policies, taking into account the priority strategies, targets and activities in the medium term;
- WHEREAS, the Regional Statistical Development Program (RSDP) 2023-2029 is necessary to serve as the regional version of PSDP in providing the statistical needs of the RSS towards the attainment of the goals and objectives of the CALABARZON Regional Development Plan 2023-2028;
- WHEREAS, the CALABARZON RSDP 2023-2029 shall comprise programs and projects which will address all the statistical issues and concerns in the region;
- WHEREAS, the RSDP will be formulated with guidance from the Regional Statistics Committee as the Steering Committee, and with inputs from the Sectoral Working Groups composed of concerned agencies;
- WHEREAS, the involvement of various departments and their attached bureaus and agencies, legislative offices, local government units, academe, private sectors and other data producers and users is fundamental in the formulation of solid, comprehensive, responsive, and attainable statistical programs for the period 2023-2029;
- NOW THEREFORE, on motion duly seconded, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to endorse to the CALABARZON Regional Development Council the request to enjoin the regional line agencies, local government units, state universities and colleges, and private sector representatives in the formulation of the CALABARZON Regional Statistical Development Program 2023-2029.
