RSC Resolution No. IV-A-14-2024

“APPROVING THE CREATION OF THE CALABARZON REGIONAL CENSUS-CBMS COORDINATING BOARD FOR THE 2024 CENSUS OF POPULATION AND COMMUNITY-BASED MONITORING SYSTEM IMPLEMENTATION”

WHEREAS, Republic Act 10625 mandates the Philippine Statistics Authority (PSA) to prepare and conduct periodic censuses on population, housing, and other sectors of the economy;

WHEREAS, the Census of Population (POPCEN) shall be a nationwide government census that involves the collection, compilation, evaluation, analysis, publication, and dissemination of data on population count, demographic and socio-economic characteristics of the population, and other relevant data in each barangay, municipality, city, province, and region in the country;

WHEREAS, Republic Act 11315, or the “Community-Based Monitoring System (CBMS) Act”, declares that the State shall adopt a community-based monitoring system that generates updated and disaggregated data necessary for targeting beneficiaries, conducting more comprehensive poverty analysis and needs prioritization, designing appropriate policies and interventions, and monitoring impact over time;

WHEREAS, PSA Board Resolution No. 4, series of 2024, declared that the POPCEN and CBMS will be simultaneously conducted from July to September 2024, with 01 July 2024 as the reference date;

WHEREAS, the 2024 POPCEN-CBMS was primarily designed to update the inventory of the population of the entire Philippines, while ensuring the updating of social registries of both national government agencies and local government units;

WHEREAS, PSA Board Resolution No. 5 series of 2024 approved the designation of the Regional Statistics Committee (RSC) as the Regional Census-CBMS Coordinating Board (RCCB), with the inclusion of other agencies, to ensure the cooperation of all government and private institutions and the seamless flow of census operations at all geographic and administrative levels for the conduct of the 2024 POPCEN-CBMS;

NOW THEREFORE, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to approve the creation of the CALABARZON Regional Census-CBMS Coordinating Board for the 2024 POPCEN and CBMS implementation;

RESOLVED FURTHER, that the CALABARZON RCCB shall be composed of regional offices of the following:


- National Economic and Development Authority – Chairperson
- Philippine Statistics Authority – Co-Chairperson
- Existing members of the Regional Statistics Committee, to include the heads or designated representatives of the following agencies/organizations as members:
 - Department of Foreign Affairs/Regional Consular Offices
 - Commission on Population and Development
 - Philippine Information Agency
 - National Commission on Muslim Filipinos
 - National Commission on Indigenous Peoples
 - Catholic Bishops' Conference of the Philippines.
