RSC Resolution No. IV-A-20-2022

"ENJOINING THE REGIONAL LINE AGENCIES AND LOCAL GOVERNMENT UNITS TO PROVIDE ASSISTANCE IN ASSESSING THE ADOPTION OF THE STATISTICAL STANDARD AND CLASSIFICATION SYSTEMS IN THE CALABARZON REGIONAL STATISTICAL SYSTEM"

- **WHEREAS,** standard classification systems are used to achieve uniformity and comparability of statistics generated at the national and international levels;
- WHEREAS, Republic Act No. 10625 or the "Philippine Statistical Act of 2013" mandates the Philippine Statistics Authority (PSA) to develop and prescribe uniform standards and classification systems in the generation of official statistics, and to coordinate with government departments and local government units (LGUs) on the promotion and adoption of statistical standards;
- WHEREAS, the Regional Statistics Committee (RSC), created pursuant to PSA Resolution No. 05, series of 2015, is tasked to oversee the implementation of policy decisions made by the PSA Board and the adoption of prescribed statistical standard and methodologies and classification systems;
- WHEREAS, the RSC through Resolution Nos. IV-A-02-2019 and IV-A-03-2022 requested CALABARZON Regional Line Agencies (RLAs), LGUs, academe and private sectors to adopt the 2017 Philippine Standard Classification of Education and 2019 Updates to the 2009 Philippine Standard Industrial Classification, respectively;
- WHEREAS, PSA Region IV-A conducted several trainings on Statistical Standards and Classification Systems for the adoption and institutionalization of statistical standards and classification systems at the CALABARZON regional statistical system/communities;
- **WHEREAS**, the PSA-Statistical Classifications Division and Regional Statistical Services Office are conducting an assessment of the adoption and implementation of the board-approved statistical classification systems at the national and subnational levels to ensure compliance;
- WHEREAS, to facilitate the assessment, the RLAs and LGUs shall accomplish the Assessment Form on the Adoption of Statistical Standard Classification System in Business Permit and License Application, as shown in Annex A, which forms part of this Resolution;
- NOW THEREFORE, on motion duly seconded, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to enjoin the Regional Line Agencies and Local Government Units to provide assistance in assessing the adoption of statistical standards and classification systems in the CALABARZON regional statistical system.
