“APPROVING THE RECONSTITUTED MEMBERSHIP OF THE CALABARZON REGIONAL STATISTICS COMMITTEE”

WHEREAS, demand for data to support development planning, implementation and monitoring of programs and projects at the local level has increased in view of the decentralization thrust of the government;

WHEREAS, the Regional Statistics Committee (RSC) was created through PSA Board Resolution No. 5 series of 2015 to serve as the policymaking body on statistical matters and as venue for discussion and resolution of statistical issues at the local level;

WHEREAS, PSA Board Resolution No. 5 series of 2015 provided that the RSC may modify its composition to provide flexibility in its operations;

WHEREAS, during the first quarter 2023 RSC meeting, it was suggested to review the composition of members and to consider the inclusion of interagency bodies for the purposes of avoiding duplication of representation;

WHEREAS, upon review and evaluation of the secretariat, the revised composition of members starting the CY 2024 is shown in “Annex A”, which forms part of this Resolution;

WHEREAS, other agencies may still be invited as guests or resource persons during RSC meetings as the need arises;


