RSC Resolution No. IV-A-08-2018

“ENDORISING TO THE REGIONAL DEVELOPMENT COUNCIL THE REQUEST FOR THE SUPPORT OF REGIONAL LINE AGENCIES, LOCAL GOVERNMENT UNITS, STATE UNIVERSITIES AND COLLEGES, AND OTHER DATA SOURCE AGENCIES IN THE IMPLEMENTATION OF THE CALABARZON REGIONAL STATISTICAL DEVELOPMENT PROGRAM 2018-2023”

WHEREAS, Republic Act No. 10625 mandates the Philippine Statistics Authority (PSA), in consultation with the PSA Board, to take the lead in the preparation of the Philippine Statistical Development Program (PSDP);

WHEREAS, the PSDP sets the strategic directions, thrusts and priorities of the Philippine Statistical System in the medium term to provide vital information support to national, sectoral and local development plans, and international commitments;

WHEREAS, the PSA Board established the Regional Statistics Committees (RSCs), through PSA Board Resolution No. 5, series of 2015, to serve as the regional counterpart of the PSA Board;

WHEREAS, the Calabarzon Regional Statistical Development Program (RSDP) 2018-2023 supports the statistical requirements of Region IV-A's Regional Development Plan for 2017-2022 and other local development plans, and integrates the statistical activities of the government to address the needs of the data users and stakeholders;

WHEREAS, the Calabarzon RSDP 2018-2023 was approved by the RSC IV-A through RSC Resolution No. IV-A-05-2018, Series of 2018 last March 8, 2018;

NOW THEREFORE, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED,** to endorse to the Regional Development Council the request for the support of regional line agencies, local government units, state universities and colleges, and other data source agencies in the implementation of the Calabarzon Regional Statistical Development Program 2018-2023.

RESOLVED FURTHER, to request all concerned government agencies to allocate funds for the RSDP implementation, monitoring and evaluation, and to submit annual report on the implementation of the statistical development programs to the PSA Region IV-A.
