**"APPROVING THE IMPROVEMENT OF DATABASES ON SECURITY, JUSTICE, AND PEACE STATISTICS OF THE CALABARZON REGIONAL STATISTICAL SYSTEM"**

**WHEREAS,** the CALABARZON Regional Statistical Development Program (RSDP) 2018-2023 recognizes the importance of data and statistics on public order, safety and justice, which would reflect the efficiency and fairness in the administration and enforcement of laws as well as the effectiveness of disaster preparedness programs;

**WHEREAS,** the CALABARZON RSDP 2018-2023 Updates recommended statistical development programs to address the issues and concerns on security, justice and peace statistics in aid of evidence-based policy and decisions;

**WHEREAS,** the Sectoral Working Group on Social Statistics agreed to strengthen coordination with all data source agencies for the generation of statistics on insurgency, illegal-drug related cases, and unified database for the whole justice system to improve the timeliness of generation, compilation and dissemination of data;

**WHEREAS,** the data to be generated by the concerned government agencies and shall be compiled by the Philippine Statistics Authority (PSA) Region IV-A in the Integrated Statistics Web Portal is shown in "Annex A", which forms part of this Resolution;

**NOW THEREFORE,** on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED,** to approve the improvement of databases on security, justice and peace statistics of the CALABARZON Regional Statistical System;

**RESOLVED FURTHER,** to request the concerned agencies to ensure the availability of the data and submit to PSA Region IV-A every last week of March or as the need arises for policy and decision making.
