PSC RESOLUTION NO. CAVITE-02-2024**

A RESOLUTION REQUESTING LOCAL GOVERNMENT UNITS (LGUs) TO PROVIDE DATA SUPPORT AND DESIGNATE FOCAL AND ALTERNATE FOCAL PERSON IN THE GENERATION OF PROVINCIAL PRODUCT ACCOUNTS (PPA)

WHEREAS, pursuant to the Philippine Statistical Act of 2013, the Philippines Statistics Authority (PSA) is the central statistical authority of the Philippine Government in primary data collection and the development of integrated social and economic statistics, including national accounts;

WHEREAS, recognizing the need to generate data on provincial accounts and to strengthen the planning and decision-making of provincial policymakers and other stakeholders, the PSA Provincial Statistical Offices of CALABARZON conducts the compilation of the Provincial Product Accounts which started in 2022;

WHEREAS in order to facilitate the conduct of Provincial Product Accounts (PPA) data collection, LGUs are requested to designate their respective permanent and alternate focal persons;

WHEREAS, sustained support of stakeholders in the provision of timely, accurate, reliable, and comprehensive data is imperative to monitor economic development at the local level;

NOW, THEREFORE, based on the foregoing premises and in motion duly seconded, be it

RESOLVED, AS IT IS HEREBY RESOLVED, to request local government units to provide data support and designate focal and alternate focal persons in the generation of the provincial product accounts for easy coordination and facilitation.
