RSC Resolution No. IV-A-11-2019

“REQUESTING THE LOCAL GOVERNMENT UNITS TO SUBMIT MONTHLY AGRICULTURAL AND FISHERY SITUATION REPORTS AT THE CITY/MUNICIPAL LEVEL TO THE PROVINCIAL OFFICES OF THE PHILIPPINE STATISTICS AUTHORITY, DEPARTMENT OF AGRICULTURE, AND BUREAU OF FISHERIES AND AQUATIC RESOURCES”

- WHEREAS,** up-to-date agricultural and fishery situation reports remains to be useful to our planners and local chief executives, and to several national government agencies;
- WHEREAS,** the data is a very important input in characterizing the sector;
- WHEREAS,** the regular agricultural and fishery surveys of the Philippine Statistics Authority (PSA) are commonly done on a quarterly basis but needs to be augmented with local agricultural and fishery data;
- WHEREAS,** there is a need to empower our Local Government Units (LGUs) to be at the forefront in reporting the actual situation of agriculture and fisheries sectors in their areas of jurisdiction;
- WHEREAS,** pursuant to the Local Government Code of 1991, powers and functions for the delivery of basic services were devolved to the local government units;
- WHEREAS,** in view of the foregoing, the PSA IV-A proposes the implementation by the LGUs of an activity entitled “Expanded Monthly Agricultural and Fishery Situation Monitoring System (EMAFSRS)” requesting the LGUs of Region IV-A to submit monthly agricultural and fishery situation reports at the city/municipal level to the provincial offices of PSA, Department of Agriculture (DA), and Bureau of Fisheries and Aquatic Resources (BFAR);

NOW, THEREFORE, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED,** to request the LGUs to submit monthly agricultural and fishery situation reports at the city/municipal level to the provincial offices of PSA, DA, and BFAR;

RESOLVED FURTHER, that the LGUs should use the prescribed format provided as Annex A and the workflow provided in Annex B;
